2. That the office of the trust shall situate at Suchitra farm, Gollahalli, Electronic city post, Bangalore-560100, and can be shifted by the mutual consent of the parties to other places.

3. That the objects for which the trust is created are:

- a. To undertake educational activities and for the purpose to construct, run and maintain schools, colleges and educational centers.
- b. To grant scholarships to the deserving students for the purpose of expanding the object of the Trust.
- c. To establish library and book banks for the benefit of the students.
- d. To purchase and maintain play grounds for the purpose of the students.
- e. To construct, maintain and run hostels for the benefit of the students.
- f. To conduct educational tours and debates for the expansion of knowledge and betterment of the students.
- g. To publish literature for the betterment of the society, students community, educational institution.
- h. To do all acts necessary and conducive to the achievement of the object or objects mentioned hereinabove.
- i. To acquire take over and run any other educational institution/institutions, training institutes of other Trusts, Society having similar objectives.
- j. To run environment protection schemes, conduct research courses, creating awareness programs among public.
- k. To conduct, organize and establish seminars, cultural activities, programmes connected to arts & cultural and other such activities which the trustees may decide from time to time.
- l. To get collaboration or to enter into Agreement with foreign schools, collages or universities or institution or companies to offer their course and conduct examination in India.

4. That the amount settled by the settlors on Trust today amounting to Rupees fifty thousand will be the initial corpus of the Trust and the trustees are hereby further empowered to collect donations from Government, Public, Public undertakings and other persons in the manner they desire.

5. That the corpus or funds of the trust not immediately required are to be deposited in the bank or to be invested in any Government security to which the trust is entitled.
6. That the trustees are empowered and to maintain bank account or accounts and to authorise any two trustees to operate on the same.
7. That it is agreed and declared that no part of the trust fund shall be utilized by the settlors or trustees for their own purpose nor they will be entitled to borrow the funds of the trust at any rate.

MANAGEMENT

8. That the trust shall be managed by the Board of Trustees.
9. That all the settlors of the trust have agreed to act as trustees and for testimony thereof have signed this Deed of Trust.
10. That the maximum number of trustees shall be 15 and not less than three at any timer.
11. That the trustees will hold their meetings atleast four times in a year but not more than an interval of four months in each meeting.
12. That the presence of three trustees personally present will be the quorum for the meeting.
13. That a trustee may resign from the trusteeship and the trustees in that meeting are empowered to accept the same.
14. That the trustees are empowered to fill up the vacancy in the Board of trustees.
15. That a person of the age of 21 years or beyond having interest in the educational activities can be taken as a trustee by the remaining trustees.
16. That the trustees who are found to work derogatory to the interest of the trust may be removed by 2/3 majority of the trustees in their meeting but before that the trustees are required to give notice to such trustee for the lapses on his part.
17. That any trustee who is leaving India for good or who remains absent continuously in three meetings without permission can be removed from the trusteeship of the trust.
18. That the trustees are empowered to reimburse for the expenses incurred for the trust and its activities out of their own funds.

ACCOUNTS

19. That the trustees shall maintain true and fair accounts of all receipt and payments of the trust and accounts so maintained shall remain at the office of the trust.
20. That the accounting year of the trust will be from April to March every year and the first accounts of the trust shall close on 31st march 2010.
21. That the trustees are empowered to appoint a Chartered Accountant for audit of the accounts of the trust yearly and to fix their remuneration of such auditors.
22. That the account so prepared and audited shall be placed before the special meeting of the trustees within 3 months of the closure of the accounts along with the report of the auditors.
23. That the account so audited shall be printed and published and may be sent to the doners of the trust and the trustees.

TRUST MEETINGS

24. That the trustees shall meet every quarter for the purpose of the trust and taking for the management of the trust and its funds.
25. That the decisions are to be taken by majority.
26. That personal presence of five trustees will be the quorum for a meeting.
27. That such meeting is to be called by giving 7 days notice to the trustees but a special meeting can be convened by a short notice 12 hours.

SPECIAL MEETINGS

28. That the trust will have in a year its special meetings before 13th June of every year in which the audited accounts of the trust are to be placed before the special meeting on the trustees... to approve and adopt such accounts and the report, but for the ensuing year shall also be lead before the meeting.

INVESTMENTS

29. That the funds collected for the trust shall be utilized for carrying out of the objects of the trust or acquiring the capital assets or constructing the building, etc., for the purpose of the trust.

30. That in case any surplus remains with the trust the same will be invested in the Government securities permitted for the trust or to remain in the bank in F.D or S.B. accounts.
31. That no part of the funds shall be invested in shares or advance for loan to others expecting the loan scholarship granted by the trustees while forming rules for the same.

NATURE OF TRUST

32. That the nature of the trust is public charitable trust and the benefit of the trust shall be available to the beneficiaries with out any distinction of casts, creed, religion or sex.

AMENDMENT IN TRUST DEED

33. That the trust deed can be amended by $2/3^{rd}$ majority of the trustees in a meeting specially called for the purpose by giving 14days notice for the purpose and the resolution passed by such majority as circulated with or without notification shall be final and winding for good for this deed.

POWERS OF THE TRUSTEES

34. That overall control of the trust shall be in the trustees who will exercise their powers and control through the executive committee of the trustees appointed by them for the purpose of through office bearers elected by them selves out of them.
- a. To acquire properties by purchase, gift, exchange, lease or otherwise land and building or other immovable property, land and buildings or other immovable property, movable stocks, securities together with all rights appertaining thereto.
 - b. To build, construct, maintain, repair adopt and alter, improve or modify any buildings and to equip the same with all facilities on the buildings, site or land belonging to the trust or on the leased or rented site, building or land as suitable to the trust.
 - c. To lease, mortgage or sell the Trust buildings, land or property for the benefit of the Trust.
 - d. To take on lease or mortgage building, land, site or property and construct building on it.
 - e. To grant receipts, to sign and execute instrument and to endorse or discount cheques or other negotiable instruments through its accredited agents.
 - f. To sue and defend all legal proceedings on behalf of the Trust.

- g. To grant fellowships, scholarships, or any monetary assistance on such terms and conditions as they may prescribe to such students, person/s as they may select for carrying on any research, investigation or study in matters which the trust is interested.
 - h. To appoint as many committees or advisory councils for the achievement or the furtherance of the object of the Trust and to assign from time to time to time such functions and duties and delegate such powers as the Trustees may deem fit in such committees or advisory councils.
 - i. To make such rules and regulations from time to time for the management and conduct of affairs of the Trust, promoted Institutions and its properties and assets.
35. That the trustees will have the following powers in general:
- a). To raise, collect or arrange for the donations for the benefit of the trust and to invest such funds from time to time.
 - b). To decide about the educational activities to be undertaken by the trust.
 - c). To make rules for running of the Institutions or giving donations or appointment of the officers and teachers as well as for the meeting held by them.
 - d). The trustees are empowered to appoint suspend and terminate or otherwise deal with the employees of the trust.
 - e). The trustees are further empowered to open and operate Bank Account or Accounts with any scheduled Bank and may exercise/authorise either of them to operate the same jointly with any of the trustees or the officers but in case of the joint operations signature of the treasurer would be essential.
 - f). To donate the funds of the trust having similar objects.

OFFICE BEARERS

36. For the smooth running of the trust the trustees are empowered to elect the following office bearers out of themselves:
- i) Chairman
 - ii) Vice-Chairman
 - iii) Managing Trustee
 - iv) Treasurer
37. That the office-bearers so elected by them shall hold office for a period of two years and every second year in the month of June there will be fresh elections but the retiring office bearers may be re-elected in the meeting called for the election of the office bearers.

38. That the chairman of the trust will be the virtual Head of the trustees and will preside over all the meetings of the trust.

- a) Sri Rajesh G Naik shall be the Chairman of the Trust for his life time.
- b) The said Sri Rajesh G. Naik shall be entitled to nominate any person as trustee to fill the Vacancy arising on his resignation or death and such persons shall be the chairman of the Board and exercise of the powers of the Chairman.

VICE-CHAIRMAN

39. The vice chairman of the trust shall act in the absence of the chairman and in his absence all meetings are to be presided by the vice-chairman. In case of the absences of the vice chairman also the trustees are empowered to elect any one out of them to preside over the meeting.

MANAGING TRUSTEE

40. The Board of the trustees are empowered to elect a managing trustee out of themselves to manage the affairs of the trust and to look after its day today business. All records of this trust shall remain in the custody of the managing trustee. Managing trustee is entitled to call for the meetings of the trust under the permission of the chairman.
41. That the managing trustee shall be empowered to represent the trust in all cases before any court or authorities.
42. That the managing trustee shall prepare the annual report of the trust and place the same before the Board of trustees.

TREASURER

43. That out of the trustees, the trustees are empowered to elect one treasurer for holding the office for a period of two years. The treasurer shall be responsible for keeping all records and maintain the account of all receipts and payments. He will be required to prepare the annual budget of the trust and will place it before the special meeting of the trust for the approval. The treasurer will also be required to prepare the final accounts to get the same audited by the auditors appointed by the Board of trustees and will place the same before the special meeting of the trustees.

WINDING UP

44. That the trust can wound up its affairs if it finds it difficult to run the activities of the trust any more but no part of the funds of the trust and its property shall revert back to the trustees.
45. That in case the trust decides to wind up its activities it may handover the corpus of the trust its assets and liabilities to another trust having same or similar objects.
46. That the Board of trustees shall call an extra ordinary meeting of the trustees for the purpose by giving 14 days notice to the trustees and a resolution passed by 2/3rd majority of the trustees present shall be the requirement of the winding of the trust.
47. That the as abovementioned settlors and the trustees who have agreed to act as trustees have signed today the mentioned hereinabove before the witnesses,

AUDIT & ACCOUNTS

48. The accounts so maintained shall be closed every year on 31st March on which date an Income and Expenditure Account for the year and Balance Sheet as on the date of closing shall be prepared to be placed before the meeting of trustees after getting the same audited.
49. The accounts of the trust are to be audited by a Chartered Accountant appointed by the trustees in their meeting. The auditor so appointed shall hold his office till the next auditor is appointed.
50. The assets and the income of the trust shall be utilized only for the object of the trust and for no other purpose. In the event of dissolution or winding up the Trust, the asset remaining as on the date of dissolution or winding up after meeting liabilities, if any of the trust, shall in no circumstance be distributed among the trustees settlors or donors, but shall be transferred to another charitable Trust, Society, Association, Institutions with similar aims and objectives and is recognized as a charitable institutions under sections 80(G) of the income tax act 1961, or the time being, as may be decided by the Board Trustees. The founder trustees, President, Members of other committees, and subcommittees, authorities, auditors or other officers or servant of the Trust shall be indemnified against or liabilities arising out of the acts and things done by him/her in the performance of the rightful duties entrusted, by way of damages otherwise and all losses, costs, charges and expenses he/she may incur or become liable by reason of any contract entered into or any act or deed done by him/her in such member, auditors, officers, servant, etc. in any way or about the discharge of his duties. If the trustees was/were acting in good faith and in proper discharge of his/her duties towards the trust.
51. The funds of the trust shall be invested in the specified under the provision of section 13(1)(d) r.w.s.11 (5) of the I.T. Act, 1961 as amended from time to time.


